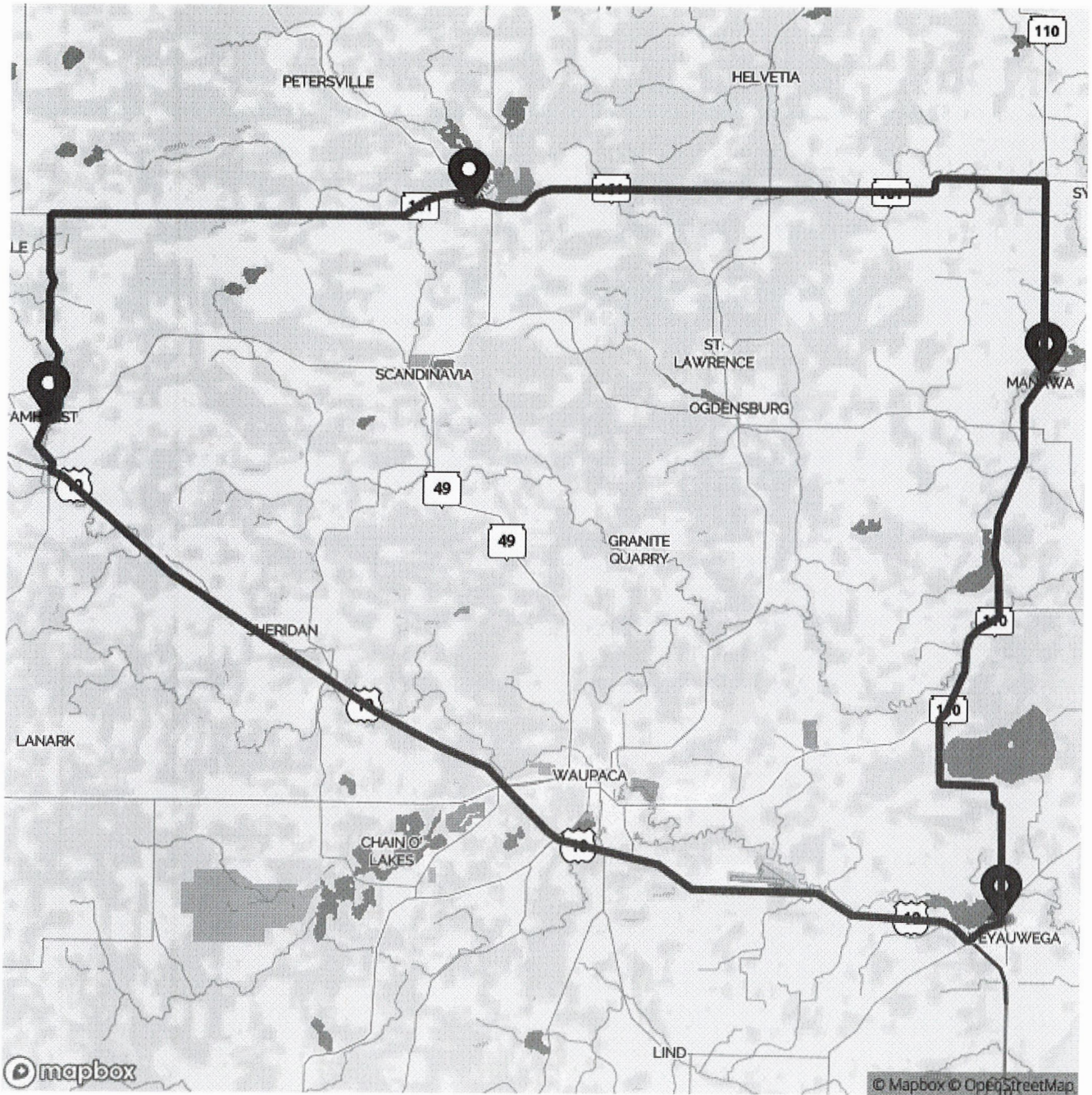

# Steve and Mary's Main Street Café

---

Steve and Mary's Café previously provided meals for the Marion, Clintonville, and New London Senior Center. The café has been in existence for 30 years and has established a great relationship in the county, with the seniors, and the community.

Unfortunately, in 2021 we needed to step back from providing Clintonville, New London, and Marion meals due to health reasons and then the unknown costs due to the pandemic.

Steve and Mary's facility is equipped with walk-in coolers and freezers, broaster, fryer, bread proofers, confection ovens, grills, etc. which can accommodate large quantities and various types of meals.

We would like to revisit the senior program with bidding on Clintonville (Bulk) and Marion (prepackaged) together for the remainder of 2022. Our bid for both centers is \$7.95 per plate.

We propose for the county to provide us with supplies due to the low count for Marion which was stated as 5-10 meals per day. If that is not possible, to have the option to purchase at cost from the county or another caterer to be an addition to the \$7.95 bid.

We miss the seniors and working with the county to provide the seniors a nutritious meal. Thank you for your time and consideration.
